Description:

The Scotch-Brite[™] Quick Clean Griddle Liquid is a ready-to-use food service griddle cleaning liquid intended for use with the Scotch-Brite[™] Quick Clean Griddle Cleaning System. The system includes:

- Scotch-Brite[™] Quick Clean Griddle Liquid 700-40 (premeasured packets) or Scotch-Brite[™] Quick Clean Griddle Liquid 701 (Quart bottles)
- Scotch-Brite[™] Quick Clean Heavy Duty Griddle Pad 746
- Scotch-Brite[™] Multi-Purpose Pad Holder 405-R
- Scotch-Brite™ Squeegee 410

Special Features:

- Effectively removes baked-on food and cooking oil from griddles.
- No rinse necessary.
- All chemical components are G. R. A. S. listed ("Generally Recognized as Safe" as compiled by FDA).
- Designed for use on mediumhot griddles (300 - 350°F.) saves cool-down time.
- Does not contain caustic soda or caustic potash.

Applications:

The Scotch-Brite[™] Quick Clean Griddle Liquid is used to remove baked-on food from hot griddles.

Check your manufacture's warranty on your griddle before using.

* For Chromium-plated or mirror-finish griddles use The Scotch-Brite™ All Purpose Scouring Pad 9488R in place of the Scotch-Brite™ Quick

Clean Heavy Duty Griddle Pad 746.

Packaging:

700-40: 3.2 fl. oz. per packet, 40 packets per case

701: 1 quart (32 fl. oz.) per bottle, 4 bottles per case

General Use Directions:

- Scrape the griddle with a spatula to remove loose food debris.
- Attach Scotch-Brite[™] Quick Clean Heavy Duty Pad 746* to Scotch-Brite[™] Multi Purpose Pad Holder 405-R.
- Pour 2 to 4 ounces (depends on size of griddle) of the liquid evenly over medium-hot griddle (300-350°F or 149-177°C).
- Immediately spread liquid around the griddle using the Scotch-Brite[™] Quick Clean Heavy Duty Griddle Pad 746* on the Scotch-Brite[™] Multi Purpose Pad Holder 405-R. Use moderate pressure to scour away burnt-on food soil.
- Move liquid into the grease trap using the Scotch-Brite™ Squeegee 410.
- For heavily soiled griddles, you may need additional liquid. Repeat step 2- 5 if necessary.
- Turn the griddle off. Wipe down the surface using a thick, wet cloth. To avoid contact with steam, move the wet cloth using the longhandled Scotch-Brite™ Multi Purpose Pad Holder 405-R.
- Season griddle with a thin coating of cooking oil. Wipe off excess oil with a dry cloth.
- Thoroughly rinse pad, pad holder and squeegee. Apply

new pad after 3-4 cleanings or when pad is no longer effective at scouring.

Coverage:

2 to 4 ounces per application, depending upon the griddle size.

<u>Storage:</u>

Store above 40°F or 4°C.

Waste Disposal Method:

As a disposal alternative, discharge small quantities of less than 5 gallons (20 liters) to a municipal or industrial waste water treatment system. Rinse empty quart container with water and recycle (No. 2 HDPE), or dispose of empty pouch in trash.

Solution **Problem** Cause Streaking, white haze or brown Griddle is too hot. Repeat the wipe down with a haze after cleaning. very wet towel using the longhandled Scotch-Brite™ Multi Purpose Pad Holder 405-R to move the towel. Seasoning oil turns brown on the Remove the darkened oil with a Time between using the griddle after cleaning. squeegee and wipe down is too wet terrycloth towel held with long-handled Scotch-Brite™ long.
